

Dear Dealer:
This is our letter to those who may be interested in being a dealer at InConJunction 30. The convention will be held July 2 - July 4, 2010 at the Indianapolis Marriott East in Indianapolis, Indiana. Nightly room rates at the Indianapolis Marriott East are $\$ 95.00$ for a single, double, triple or quad. There are a limited number of room upgrades available. Nightly rates for upgrade rooms range from $\$ 105$ to $\$ 145$. To make reservations call 317-352-1231. The reservation deadline is June 1, 2010. Please be sure to tell the hotel that you are with "InConJunction" and/or mention group code "ISFISFA" when reserving your rooms. Table price is $\$ 50$ per table. There are no convention registrations included with any of the tables. Everyone in the Dealers' Room, Dealers included, must have an InConJunction 30 badge. Dealers who get their applications in on time (by March 30th) will get a special preregistration price of $\$ 30$ per person. (Those Dealers who apply for tables but do not get them can still take advantage of this special registration price. Simply contact me if this is the case.) Registrations can also be bought at the convention for $\$ 45$ per person. Tables are 6'x30". The Dealers' Room will contain about 60 tables. Please limit yourself to only the number of tables you need. This year's Dealers' Room will once again be juried.
